The specific war risks covered by the Institute War and Strikes Clauses (Hulls) (IWSC(H)(95)) are enumerated in cll 1.1, 1.2 and 1.3; these risks mirror the war risks excluded by cl 24 of the ITCH(95). 11 Identical war risks are also covered by cll 1.1, 1.2 and 1.3 of the Institute War Clauses (Cargo) (IWC(C)(82)) 12 and, yet again, those war risks mirror the war risk exclusions contained within cl 6 of the ICC (A), (B) and (C).

### **INSTITUTE TIME CLAUSES HULLS - Mar Risk**

Following an extensive period of world-wide consultation going back to 2006, the Joint Cargo Committee released revised Institute Cargo Clauses A, B and C, along with accompanying Institute Cargo Clauses War and Institute Cargo Clauses Strikes, on 24 November 2008. 2009 Clause Revisions Copies of both "Clean" and "Specimen" versions of all clauses revised in 2009 are available from the list below:
