The law requires restitution fines in every criminal case in which an adult offender is convicted of a crime, unless a judge finds compelling and extraordinary reasons the offender should not pay a fine. Fines for adults convicted of misdemeanors range from \$150 to \$1,000. Adults convicted of felonies must pay between \$300 to \$10,000.

### **Restitution - CA Victim Compensation Board**

Case law in Florida interprets the statute to mean that an insurer qualifies as a "victim," as "Florida's restitution statute requires the trial court to consider the amount of the loss sustained by any victim," and further stated that an insurer would be subrogated to the rights of its insured.
